## Mosspark and Cardonald

(Traffic Regulation) Order 201\_

Glasgow City Council propose to consider the introduction of a Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

This Order will keep areas of the road, unsuitable for parking or loading, clear of vehicles. It will also introduce enforceable disabled parking bays which are currently advisory.

The area affected by this proposal is generally bounded by:

## **East of Corkerhill Road**

Mosspark Boulevard to the North, Dumbreck Road to the East and M77 to the South.

## West of Corkerhill Road

Tarfside Avenue to the North, Kinnell Avenue to the South and Mosspark Drive to the West.

The roads affected by these proposals are:

Airth Drive, Airth Lane, Alcaig Road, Alness Crescent, Alva Gardens, Alyth Gardens, Ardwell Road, Arisaig Drive, Arisaig Place, Aros Drive, Arran Drive, Ascaig Crescent, Ashdale Drive, Ashkirk Drive, Auldbar Road, Auldgirth Road, Aviemore Road, Balblair Road, Balerno Drive, Balloch Gardens, Bellahouston Drive, Clunie Road, Corkerhill Road, Gauldry Avenue, Hardridge Road (north portion), Hardridge Road (Corkerhill Road Service Road), Hardridge Road (south portion), Kinnell Avenue, Kinnell Place, Kirriemuir Avenue, Lammermoor Avenue, Monifieth Avenue, Muirdrum Avenue, Mosspark Avenue, Mosspark Boulevard, Mosspark Drive, Mosspark Oval, Mosspark Square, Tanna Drive, Tannadice Avenue.
