



## The Glasgow City Council (City Centre) (Traffic Management) Order 2010 (Variation No.26) (Congestion Improvement) Order 201\_

### Report

Glasgow City Council propose to consider the introduction of the above named Traffic Regulation Order which would extend a number of existing waiting and loading restrictions to include Sunday as well as extend parking charges to include Sunday.

Glasgow City Council's Local Transport Strategy sets out the Council's aspirations for taking forward transport policy and infrastructure within Glasgow. This strategy contains the high level objectives which relate to these proposals:

- Support the continuing physical, social, economic, cultural and environmental regeneration of the City by maintaining and promoting efficient and effective transportation services and infrastructure within Glasgow;
- Promote healthy and environmentally sustainable methods of transport that minimise harmful emissions and energy consumption including those that involve physical activity

From these aforementioned objectives, the Council has set the following traffic and demand management policy:

- Ensure provision of adequate short term parking for business, shopping and tourism.

In view of the above, and the lack of parking availability on a Sunday within the City Centre, it is considered necessary to extend a number of existing waiting and loading restrictions to include Sunday as well as extend parking charges to include Sunday.

In addition to this, increasing on-road parking availability on a Sunday will improve traffic flow within the City Centre and have a positive effect on environmental issues such as air quality by encouraging the use of more sustainable methods of transport. These proposals would also encourage the use of off-street parking options if driving into the City Centre and likely reduce any time spent driving around the City Centre roads for those looking for an available on-street parking space.

To facilitate taxi provision in the City Centre certain taxi ranks will be extended or introduced as part of this proposed order.

Following development works at Strathclyde Sports Facility, the temporary restrictions currently in place on St James Road will become permanent as part of this proposed order.

Also included as part of these proposals is the administration of cashless parking payments and paperless virtual parking permits.

Albion Street (between Bell Street and Blackfriars Street) – east side

- Conversion of existing no waiting during Monday to Saturday 8am to 6pm, no loading or unloading during Monday to Saturday 8am to 6pm except goods vehicles, to a 24 hour taxi rank

Buchanan Bus Station Service Road (access road off of Cowcaddens Road, to the north of Buchanan Bus Station) – south side

- Introduction of a 24 hour taxi rank

George Square (north section) – south side

- Conversion of existing parking bays to a 24 hour taxi rank

George Square (west section) – east side

- Conversion of existing parking bays to a 24 hour taxi rank

Holland Street (between Bath Street and Bath Lane) – east side

- Conversion of existing parking bays to a 24 hour taxi rank

Osborne Street (between Dunlop Street and Stockwell Street) – north side

- Conversion of existing no waiting at any time, no loading at any time to a 24 hour taxi rank

Queen Street (between George Square and Ingram Street) – west side

- Introduction of a Friday, Saturday, Sunday, 11pm – 4am taxi rank

St Vincent Place (between Buchanan Street and George Square) – north side

- Conversion of existing parking bays to a 24 hour taxi rank

The following temporary restrictions currently in place on St James Road will become permanent as part of this proposed order which will comprise of:

St James Road

- No waiting and no loading / unloading at any time (as currently exists);
- No waiting at any time / no loading or unloading at any time except goods vehicles (as currently exists);
- Parking places Outer Area, pay and display during Monday to Saturday (changing to Monday – Sunday) 8am to 6pm, Zones L, M, N and S (as currently exists);
- Disabled vehicles parking places Outer Area (as currently exists)
