## NOTICE OF PROPOSALS

## Mount Florida (Traffic Regulation) Order 201\_

Glasgow City Council proposes to consider the introduction of the above named Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

The roads affected by these proposals are bounded by:

Queen's Drive and Nutberry Court to the north, Aikenhead Road to the east and the railway line to the south and west.

Details of the proposals are as follows:

- 1. No waiting and no loading/unloading at any time restrictions
- 2. No waiting and no loading/unloading at any time except taxis
- 3. No waiting at any time restrictions
- 4. Goods vehicle loading only
- 5. Loading only places 8am 6pm to allow for loading and unloading by any class of vehicle
- 6. One way operations
- 7. Prohibition of right turn
- 8. Prohibition of left turn.
