## NOTICE OF PROPOSALS

### **City Centre** (Traffic Management) Order 2010 (Variation no.27) Order 202\_

Glasgow City Council proposes to consider the introduction of the above named Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984, as amended.

The roads affected by these proposals are located within Glasgow City Centre. THE LIST OF ROADS AFFECTED BY THESE PROPOSALS ARE

Blythswood Square, Bothwell Street, Candleriggs, Cochrane Street, Douglas Lane, Elmbank Street, Hanover Court, Holland Street, Hutcheson Street, North Frederick Path, North Frederick Street, South Portland Street, Trongate, West Campbell Street and Wilson Street.

#### DETAILS OF THE PROPOSALS ARE AS FOLLOWS

- 1. No waiting and no loading/unloading at any time.
- 2. No waiting and no loading/unloading at any time, except by goods vehicles.
- 3. No waiting at any time, no loading/unloading during Monday Sunday, 8am - 6pm, except by goods vehicles.
- No waiting during Monday Sunday, 8am 6pm and no loading/unloading during Monday - Sunday, 8am - 6pm, except by goods vehicles.
- 5. Electric vehicle parking places for use by electric vehicles charging only (permits would not apply) with a maximum stay time of 2 hours within the City Centre Inner Area.
- 6. Electric vehicle parking places for use by electric vehicles charging only (permits would not apply) with a maximum stay time of 3 hours within the City Centre Outer Area.
- Motorcycle parking places for use by solo motorcycles only without limit of time.
- 8. Administrative change of the street name previously known as Hanover Court, to North Frederick Street and North Frederick Path.
