NOTICE OF PROPOSALS

Laggan Road (Traffic Regulation) Order 202_

Glasgow City Council proposes to consider the introduction of the abovenamed Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984.

The Council are aware of road safety concerns regarding the speed and volume of vehicular traffic using Largie Road, Coylton Road and Laggan Road as a through route to avoid the traffic signals at the junction of Merrylee Road/ Langside Drive. To address these concerns, a 'Prohibition of Driving (except pedal cycles)' restriction is proposed to prevent this practice.

THE ROADS AFFECTED BY THESE PROPOSALS ARE BOUNDED BY: Merrylee Road, Largie Road, Laggan Road and Langside Drive.

THE LIST OF ROADS AFFECTED BY THESE PROPOSALS ARE:

Largie Road, Coylton Road and Laggan Road.

DETAILS OF THE PROPOSALS ARE AS FOLLOWS:

- The introduction of a 'Prohibition of Driving (except pedal cycles)' restriction
- The introduction of no waiting at any time restrictions.

Report

The Council are aware of road safety concerns regarding the speed and volume of vehicular traffic using Largie Road, Coylton Road and Laggan Road as a through route to avoid the traffic signals at the junction of Merrylee Road / Langside Drive. To address these concerns, a 'Prohibition of Driving (except pedal cycles)' restriction is proposed to prevent this practice.

Glasgow City Council's Local Transport Strategy includes a high-level objective within improving road safety. This is: -

• To improve the safety and the actual and perceived security of travelling within the City by reducing accidents and enhancing the personal security of all users of the transport network

To achieve this objective the Council has agreed the following transport policy which is relevant to this proposal, as follows: -

• Continue with a holistic approach to road safety work, integrating engineering, education, enforcement and encouragement and evaluation

The policy stated above can be achieved by: -

- Prohibiting this area being used as a through route for vehicular traffic
- Introducing waiting restrictions to prevent obstructive and inconsiderate parking adjacent to the physically restricted area

Specifically, these proposals have been designed in line with the policies above and seek to contribute to achieving these objectives by: -

- Improving road safety by reducing the volume of vehicular traffic passing through a residential area
- Creating a safer and more attractive environment for pedestrians and cyclists by reducing the volume of vehicular traffic
- Encouraging vehicular traffic to use local distributor roads as oppose to minor residential roads

Each element of the proposal is detailed below: -


Prohibition of Driving (except for pedal cycles)

This restriction will prohibit the area being used as a through route by vehicular traffic.

No Waiting at any time

This restriction is proposed where waiting is deemed unsafe or undesirable.
