Planning Policy Update

Following <u>adoption of the Local Plan 2</u> in November 2022, the Land Planning Policy team has commenced early work on a new plan – Local Devleopment Plan 3 (LDP3). LDP3 must support the objectives of <u>wider planning reforms</u> being introduced by the Scottish Government under the Planning (Scotland) Act 2019.

The Planning (Scotland) Act 2019 established a new legislative framework for the planning system. Under the Act, National Planning Framework 4 (NPF4) will now form part of the statutory development plan, meaning that its policies have a stronger role in day-to-day planning decision making compared to NPF3. NPF4 was adopted by the Scottish Government on 13 February 2023, replacing NPF3 and Scottish Planning Policy. The spatial and thematic policies in NPF4 will strongly influence the spatial strategy and local planning policies that will form part of LDP3.

We are currently preparing a Development Plan Scheme (DPS), which will set out how the LDP3 will be prepared, including a timetable and participation statement outlining how people can get involved in the process. The DPS will be published later in 2023. Alongside this, our early work will be focused on gathering evidence and data that will help to inform the preparation of LDP3. This evidence and data will be collected in collaboration with a range of stakeholders including key agencies, community organisations and the public at large including young people.

The diagram below sets out the key stages that will form part of the LDP3 plan preparation process:
